



# The Older Generation is not Respected under the Designs of Capitalism

#### News:

A mentally ill man who starved to death after his benefits were stopped was left at risk of "serious harm" by the government, the High Court has heard.

Errol Graham's emaciated body was found in June 2018 when bailiffs broke into his Nottingham flat to evict him.

His family believe the Department for Work and Pensions' (DWP) handling of the 57year-old's case was unlawful and breached his human rights.

Their case is being heard in the High Court. (BBC, 12<sup>th</sup> January)

## Comment:

The fact that he was left for so long unchecked to the extent that he starved to death is a very common experience of the many elderly. In Western societies, the principle of individualism dominates over the collective responsibilities we have to each other as humans. If they are not able to contribute a useful function, their purpose and value are reduced. This is seen clearly in that the need to visit him was only because there was a material loss of money from the landlord of the property.

Great reward is expressed in Islam for respecting and looking after the needs of the elderly. It is their right, without question, to have money for all of their life for their needs.
